- 2. The student must be a high school senior and accepted at an accredited college or university, or be an Adele DeLeeuw scholarship recipient currently in college at the time of application. Previous Adele DeLeeuw scholarship winners may re-apply by submitting a new application. <u>All</u> applicants must submit application with a complete, official transcript of grades.
- 3. The student must principally engage in further education in one or more of the following areas of study: art, poetry, writing, journalism, and engineering. The student must demonstrate the scholastic aptitude and interest to pursue such study.
- 4. The student must demonstrate financial need.

Application for consideration may be made <u>only</u> through completion of this Application for Adele DeLeeuw Scholarship which should be sent to the address below.

- Upon consideration of the application, the applicant may be requested to appear for an interview before the selection committee.
- The completion of an application and any subsequent interview does not automatically
